National Show



This agreement entered into, on _____(date) by and between the Ohio State Rabbit Breeders Association, Inc (OSRBA, Inc) and _____(club name) _____(acronym). To host a National Show on _____(date) at the Ohio Exposition Center O'Neill and/or Voinovich building in conjunction with the OSRBA, Inc annual mini convention held in Columbus, OH. The building and location is subject to change without notice.

Whereas the parties herein desire to set forth their respective responsibilities as they relate to said show: Now therefore, and in consideration of the mutual premise of the parties herein it is agreed as follows:

1. _____(acronym) shall pay a show exhibiting fee per animal entered in the amount of \$3.50 per animal entered. A copy of the rabbits entered must be submitted at the OSRBA show office with final payment by Saturday at 6:00 PM, when the office closes. If payment is not made by the designated time, then the deposit is also nonrefundable. Copies of the show entry form can be copied at the show office free of charge. If entries are turned into the office by the time above the deposit will be subtracted from the total monies owed to OSRBA, if the deadline is not met then the deposit will be forfeited. All national show contracts must be in by **February 1** with a \$35 deposit. All specialty show contracts must be in by **February 1** with a \$35 deposit to have an advertisement in the OSRBA, Inc. show catalog. Late specialty show contracts will be accepted until March 25 with a \$50 deposit. ***No shows will be held without a signed contract. Checks must be made payable to Ohio State Rabbit Breeders Association Inc.***

2. The payment for said fees shall include the following:
 - Building and facilities
 - Security for building
 - General liability insurance
 - Coops and bottom boards
 - Set up and tear down of coops
 - Clean up before, during, and after show
 - Consulting service as required
 - Judging tables, judging coops, holding coops, and scales
 - Initial shavings in coop (if additional shavings are needed they must be provided by the exhibitors or the breed club)

3. It shall be the responsibility of the _____(acronym) to provide the following:
- The total number of coops requested must be submitted in writing to Laurie Norman (OSRBA Secretary) by **11:59 PM EDT the Monday prior to the OSRBA Mini Convention weekend.**
 - **Any materials used in or around coops must be removed by 2:00 PM on Sunday** (included but not limited to cardboard dividers, feed and water cups, coop tags, and decorations)
 - Provide and compensate judge(s) for their **entire** bid. This includes but is not limited to judging fees, hotel, parking fees, and travel expenses.
 - Hosting the show with club personnel.
 - Show Catalog.
 - ARBA and specialty breed sanctions.
 - Airport, parking fees, and other transportation of exhibitors, and animals.
 - Feed and water cups.
 - All rabbits **MUST BE REMOVED FROM COOPS BY 2:00 PM ON SUNDAY**

Additional Information:

- Club booth cost will be provided on booth contracts. Booth space is 8'x10'. There will be one table and two chairs provided. No side drapes or table cover will be provided. Any drapes must be flame retardant.
- No other animals allowed in the building other than rabbits and cavies except service dogs.

- signing this agreement arising out of the contract and all other aspects as is related to National, Regional, and State Specialty Show(s).
- Parking passes can be purchased at the gate contact the Ohio Expo Center for pricing
- Camping permits can be purchased at the gate with full-service electric, water, and sewage. Subject to first come first serve. Contact the Ohio Expo Center for price
- No animals in the showroom before Friday at **NOON Eastern Time.**
- *National shows are limited to Saturday of the weekend and any specialty in conjunction may be held on Sunday. Specialty shows are limited to one per day.*
- **Any payment to judge(s) by the sponsoring club will not be subtracted from monies owed to OSRBA**
